THESE CENTERS PROVIDE INDIVIDUALS WITH ACCESS TO CASE MANAGEMENT, ACCESS TO MAIL SERVICE, COMPUTER LABS, PHONE AND FAX ACCESS, CLOTHING REFERRALS, FOOD REFERRALS, AND BUS TICKETS. THROUGH OUR EMPOWERMENT CENTERS WE ALSO RUN OUR FINANCIAL ASSISTANCE PROGRAM WHICH PROVIDES ASSISTANCE SUCH AS FUNDS TOWARDS UNDERPAID OR OVERDUE BILLS INCLUDING RENT, ELECTRIC, WATER, FINES & FEES, BIRTH CERTIFICATES, STATE IDS.

FRIENDSHIP HOUSE RUNS A FOUR STAGE TRANSITIONAL HOUSING PROGRAM FOR INDIVIDUALS SEEKING SELF-SUFFICIENCY AFTER EXPERIENCING A CRISIS THAT LEFT THEM HOMELESS AND ALONE. PARTICIPANTS ("RESIDENTS") COME FROM INCARCERATION, RESIDENTIAL DRUG/ ALCOHOL REHAB, HUMAN TRAFFICKING SHELTERS OR DOMESTIC VIOLENCE SHELTERS. WHILE IN THE PROGRAM, RESIDENTS ARE ASKED TO FIRST FOCUS ON THEIR RECOVERY BEFORE SEEKING EMPLOYMENT, ONCE THEY HAVE SHOWN THEY ARE STABLE AND READY, RESIDENTS BEGIN NEXT STEPS INCLUDING JOB SEEKING. RESIDENTS ARE OFFERED GUIDANCE WITH RESUME BUILDING AND INTERVIEW SKILLS AND THEY START FOCUSING ON FINANCIAL LITERACY TRAINING FROM STAFF INCLUDING BUDGETING AND REQUIRED SAVING. RESIDENTS LEARN MANY LIFE SKILLS WHILE IN THIS PROGRAM INCLUDING BASIC HOUSEKEEPING, ROOM SHARING, MEAL PLANNING, WORKING THROUGH DIFFICULT
